## Basic Terms and Condition Europear Rwanda

### 1. RENTAL REQUIREMENTS AND PAYMENT

At the time of rental, the following must be provided:

- 1.1 EUROPCAR RWANDA approved method of payment/or credit card which can be Visa, Mastercard or Amex
- 1.2 Full names; residential, postal and physical addresses; and telephone number.
- 1.3 Local contact details, credit card details & passport copy.
- 1.4 A valid, original driver's licence and original passport or identity document
- 1.5 Account holders must produce all of the above including an official company order.

#### 2. GENERAL

- 2.1 'Renter' refers to any party to this agreement whether the driver, additional driver, authorised signatory or qualified payer.
- 2.2 Vehicles are rented subject to EUROPCAR RWANDA RWANDA's standard terms and conditions as reflected herein.
- 2.3 Please refer to the EUROPCAR RWANDA RWANDA's website www.EUROPCAR RWANDA rw

for all rates, fees, liability amounts, applicable fees and any other charges for extras.

- 2.4 Daily rates are calculated strictly in cycles of per day dates basis, from time of pick up to time of drop off.
- 2.5 Should a vehicle require valet cleaning, the valet charges will be billed directly to the Renter's credit card and /or account.
- 2.6 The Renter is liable for any towing, storage, release, glass, tyres, rims, body, water and under-carriage damage to vehicle
- 2.7 Vehicle maintenance is included in the rate. Fuel is not included in any quoted rate.
- 2.8 An additional fee will be charged for an additional driver at \$20 net per day or a younger driver (under age of 23) at \$20 net per day, provided that they are in possession of a valid, unendorsed driver's licence for a minimum of 2 years.
- 2.9 All vehicles are rented as per 150 KMs per day basis; and it is customers responsibility to check traffic fines from police website or irembo website. EUROPCAR RWANDA is not liable to able any late fees charges. All charges will be charged to customer.
- 2.9.1 The rent mentioned on the website are for Rwanda all locations except the National Parks and cross border travel, wherein only SUV vehicles are allowed to go inside the national parks e.g. Akagera National Park, Volcano and Gorilla Trekking etc.
- 2.9.1(a) The renter must inform for any such travel itinerary to the front office executive at the time of check out formalities, an additional charge of USD 50 + taxes i.e. USD 59 net per day will be applicable to be paid by the renter
- 2.9.1(b) The renter must inform for any cross border travel itinerary to the front office at the time of check out formalities
- 2.9.1© an additional charge of USD 100 + taxes i.e. USD 118 net per day will be applicable to be paid by the renter for the vehicle
- 2.9.1(d) Only Chauffer drive is allowed for all SUV's (e.g. PRADO, V8 and premium vehicles); Additional USD 25 for National Parks & USD 50 for cross border travel, will be applicable against boarding and lodging cost for drivers

## 3. DRIVING REQUIREMENTS

- 3.1 Rwandan Government Legislation requires that whilst driving, the driver is required to have a valid driver's licence in their possession.
- 3.2 EUROPCAR RWANDA requires that a driver/s must have obtained their licence at least two years prior to renting a vehicle and be over the age of 23 years.

## 4. COLLISION DAMAGE/THEFT WAIVERS

4.1 Standard waiver only is available for the reduction of liability in the event of loss, theft and/or damage to the vehicle which is 10% of the quotation from the garage or the value insured of the vehicle with min. excess rates as per the grid below in any event of accident / damage to the vehicle whichever is higher.

- 4.1 Standard waiver and Super waiver options are available for the reduction of liability in the event of loss, theft and/or damage to the vehicle which is 20% of the quotation from garage or value insured.
- 4.2 The Renter will be responsible for the full replacement value of the vehicle, should theft/loss/damage be caused due to wrong and/or illegal actions or omissions (see Section 6 below for a detailed list of factors that negate cover/waivers).
- 4.3 An accident administration fee will be applied and charged to the Renter's credit card or account, in the event of damage/loss/theft of the vehicle which is \$200 USD net for loss of rent surcharge.

## 5. DAMAGE/THEFT / LOSS

- 5.1 The Renter is required to contact EUROPCAR RWANDA immediately in the event of theft, loss or damage and a full report must be made to the nearest Police Station within 12 hours where an accident has occurred and within 6 hours in the case of loss/theft. A Police Services Case Reference number must be obtained from the Police Station.
- 5.2 An Incident Report must be completed; these are obtainable from any EUROPCAR RWANDA branch.
- 5.3 Where the vehicle is not drivable, phone EUROPCAR RWANDA and an authorised towing company will be appointed to uplift the vehicle.
- 5.4 EUROPCAR RWANDA reserves the right to provide a replacement vehicle. Within Kigali 2-3hours, outside Kigali will be depending on the location of client. Before 12hours the vehicle will be replaced.
- 5.5 Personal belongings stolen or lost during an incident are not covered. Personal baggage insurance can be purchased prior to rental.

## 6. FACTORS THAT NEGATE WAIVERS

- 6.1 Gross negligence
- 6.2 Any wrong and/or illegal actions or failure to act which results in damage or loss.
- 6.3 Driving under the influence of alcohol or substances that diminish your capacity.
- 6.4 Unauthorised persons driving the vehicle.
- 6.5 Taking the vehicle across any border without authorization.
- 6.6 Not adhering to traffic, road and driving regulations.
- 6.7 Unsuitable driving or road conditions including unsurfaced roads
- 6.8 No other vehicles or third party involved in a collision unless exceptional circumstances apply and are proven.
- 6.9 Not reporting the collision to EUROPCAR RWANDA and the nearest Police Station within 12 hours. A Police report reference number must be obtained from the Police Station.
- 6.10 Failure to obtain authorisation from EUROPCAR RWANDA and effect payment for the extension of the contracted rental period.
- 6.11 Failure to report the theft of a vehicle to EUROPCAR RWANDA and a Police Station within 6 hours of the event. A Police report reference number must be obtained from the Police Station.
- 6.12 Failure to produce the vehicle keys in the case of theft unless exceptional circumstances apply and are proven.
- 6.13 Failure to report the exact details of the last known location of the vehicle prior to theft.
- 6.14 Not using the vehicle for its intended purpose, for example carrying animals, unlawful and unsuitable goods. Except Toyota Fortuner, Toyota Prado or Land Cruisers other cars are not allowed to travel inside national park and renter shouldn't use the vehicle for agricultural purposes without prior authorization.
- 6.15 Driving without due care and attention unless exceptional circumstances apply.

### 7. THIRD PARTY CLAIMS

- 7.1 Should the Renter be involved in an accident where the fault was not that of the Renter, the Renter is responsible and liable for the non-waiver able excess liability until a third-party recovery has been made by EUROPCAR RWANDA RWANDA. EUROPCAR RWANDA will reimburse the Renter the amount paid less the accident administration fee.
- 7.2 For full third-party claims there will be an additional third-party handling charge of \$300.
- 7.3 For third party claims where fault is with the renter, EUROPCAR RWANDA will settle claims through our insurance not exceeding \$100,000 total liability above this is billed to the customer.

### 8. TRAFFIC FINES & TOLLING FEES

- 8.1 Should the Renter disobey traffic regulations which results in a fine, such amounts will be directed to the Renter of which Renter must settle direct to the relevant authorities. If not, the Renter will be charged an accident administration fee in addition to the fine.
- 8.2 All toll fees charged during the rental period will be for the Renter.

## 9. CROSS BORDER: Subject to approval from EUROPCAR RWANDA

- 9.1 A letter of authorisation or confirmation must be requested from EUROPCAR RWANDA at the time of reservation for all cross-border travelling. All necessary documentation regarding the vehicle must be obtained from EUROPCAR RWANDA 48 hours before crossing the border.
- 9.1.1 **COMESA insurance** is **mandatory** to be procured at least **24-48 hours prior** to cross border travel date, the cost of **COMESA Insurance** is based on number of days to be procured from insurance company and **renter is liable to pay the cost of COMESA insurance** as per the quotation from the insurers **on actuals** (approximate cost for 3-4 days is USD500 for COMESA Insurance).
- 9.2 EUROPCAR RWANDA will not be held responsible if a Renter is refused entry into another country.
- 9.3 The Renter will pay for any cross-border fees that may arise whilst crossing the border.
- 9.4 A non-refundable cross border fee will be levied by EUROPCAR RWANDA for vehicles crossing the border and is payable directly by the Renter.
- 9.5 An accident administration fee will be levied should an accident/theft occur outside the borders of Rwanda according to Section 6. All costs and fees that are incurred to retrieve vehicle and assist Renter will be charged direct to the Renter.

# 10. DELIVERY & COLLECTION

- 10.1 Any toll fees, fuel or game park entrance fees will be billed in addition to a delivery or collection charge
- 10.2 The Renter shall take delivery of the vehicle at the place specified on the Rental Agreement. The renter shall have no claim against EUROPCAR RWANDA if the vehicle is not available for delivery, other than a refund of any amount paid or pro rata thereof.
- 10.3 Where delivery takes place outside of the place and time specified, the Renter's acceptance of delivery shall not constitute the delivery as being unsolicited.
- 10.4 On the return date the Renter shall return the vehicle at Renter's risk and expense to EUROPCAR RWANDA at the place specified in the Rental Agreement and the keys must be handed to a EUROPCAR RWANDA authorized representative and the vehicle be parked in a designated parking bay and locked. The vehicle shall be returned undamaged, in good order and in roadworthy condition, fair wear and tear accepted.
- 10.5 The vehicle shall be at the Renter's sole risk from the date of delivery up and until the vehicle is returned to EUROPCAR RWANDA
- 10.6 By the Renter's signature hereto the Renter acknowledges that the vehicle is delivered by EUROPCAR RWANDA free of any damage whatsoever and in good order and repair unless such damage is recorded in writing and signed by both parties on the Rental Agreement or on the vehicle condition document.
- 10.7 In the event of the vehicle's keys being placed in a drop-off safe as a result of the designated return location being closed, then the parked vehicle shall be at Renter's sole risk of loss or damage until EUROPCAR RWANDA has recorded the return thereof.
- 10.8 Failure to return the vehicle in terms of this agreement shall constitute illegal possession by Renter and EUROPCAR RWANDA may repossess the vehicle wherever same may be found and from whomsoever is in possession thereof.
- 10.9 Free delivery within 10kms of the EUROPCAR RWANDA Downtown Depot located at KIYOVU, Kigali, Rwanda.
- 10.10 One-way rentals are available at the prescribed fee. These drop off charges are billed direct to the renter. One-way rentals to a non-EUROPCAR RWANDA office are available on request.

## 11. OPTIONAL ACCESSORIES

- 11.1 These are available on request at the time of reservation or rental and any fees or applicable limited liability amount will be charged to the Renter at the time of rental.
- 11.2 In the interest of safety EUROPCAR RWANDA representatives will not fit any accessories for the Renter; the Renter is responsible for the fitting of any accessory rented.

## 12. DEPOSITS - LIABILITY & FUEL

- 12.1 An excess insurance deposit is required for the applicable excess liability on initiation of the rental. The Renter must be in possession of a credit card irrespective of product selection. The deposit is rental amount + \$500 USD in cash.
- 12.2 Each vehicle is refuelled on termination (if applicable) irrespective of whether Renter has filled the fuel tank or not and the Renter may be liable for an additional refuelling charge + surcharge of \$25 USD.

### 13. EXTENSION OF RENTAL

13.1 If the Renter wishes to extend the rental beyond the original return date, authorisation must be obtained from EUROPCAR RWANDA Failure to do so will result in breach of all terms and conditions and EUROPCAR RWANDA will immediately negate all waivers.

13.2 Additional rental days will be charged directly to the Renter's account or credit card at the prescribed rate.

### 14. EXEMPTION

14.1 Unless any wrongdoing can be proven against/ attributed to EUROPCAR RWANDA RWANDA, its agents or employees, EUROPCAR RWANDA shall not be liable for any damage or loss, whether direct or indirect, arising out of any defect in or mechanical failure or the safety of the vehicle or the driving or use thereof, nor for any direct or indirect loss, consequential damages, loss of profits or special damages arising out of any of the foregoing. EUROPCAR RWANDA does not accept any liability for any loss of or damage to any property transported in or left in the vehicle or any other damages or loss as a result of the conveyance of the driver and/or any other passengers. No warranties as to the condition, state of repair, performance capabilities, year of manufacture, odometer reading or anything else concerning the vehicle are given by EUROPCAR RWANDA RWANDA.

### 15. LEGALITIES

- 15.1 All notices and legal processes in terms hereof shall be given to the Renter at the address set out in the rental agreement (Renter's chosen legal address). Any notice posted to Renter shall be deemed to be received 7 days after posting, unless the Renter proves the contrary, to FUROPCAR RWANDA
- 15.2 The Renter consents to the geographic area of the Magistrate's Court having authority over its person in respect of any proceeding arising from this agreement even if the amount in issue would otherwise exceed the authority of such court. This consent shall not however, prejudice EUROPCAR RWANDA in respect of their right to proceed in any court of competent authority.
- 15.3 The English version of this agreement will prevail in the event of a dispute.
- 15.4 This is the entire agreement and no variation or cancellation shall be valid unless in writing and signed by the Renter and EUROPCAR RWANDA RWANDA.
- 15.5 EUROPCAR RWANDA may claim and recover from Renter on demand all costs and expenses incurred by EUROPCAR RWANDA in consequence, directly or indirectly, of any breach by Renter of this agreement, including attorney-and-client costs, collection commission and any costs of tracing Renter or the vehicle.
- 15.6 A provision of this agreement which is invalid or unenforceable for any reason shall be severable from the rest of this agreement and shall not affect the validity thereof.
- 15.7 This agreement shall be governed by the laws of the Republic of Rwanda.
- 15.8 By the Renter's signature hereto, the Renter accepts all the charges charged by EUROPCAR RWANDA in terms of this agreement, including any charges relating to loss and damage to the vehicle.
- 15.9 By Renter's signature hereto, Renter hereby authorizes EUROPCAR RWANDA to conduct reference checks or any other checks required by law on Renter, if necessary.

## 16. Cancellation Policy

16.1 EUROPCAR RWANDA will charge the renter \$50 cancellation fees if the Renter cancels before 24 hours from the time of rental. In case the Renter cancels after 24 hours 1 day rent cancellation fees applies which will be charged to the Renter.

## 17. Chauffeur Driven Service:

17.1 Chauffeur service is available (meaning renting car with a EUROPCAR RWANDA driver) on all chauffeur rental station.

## 18. No show Fees:

18.1 A no show fees per day rent as per the vehicle booked will be invoiced to the client or the renter counter in case of no show.

## 19. Tax:

19.1 In Rwanda 18% VAT is applicable in all services rented.
